**AN ORDINANCE AMENDING SECTION 10.25 SCHEDULE OF FINES AND FEES  
OF THE TOWN OF THORNTOWN, INDIANA  
CODE OF ORDINANCES**

WHEREAS, the Town Council of the Town of Thorntown (“Town Council”) passed Ordinance 2020-07 on June 15<sup>th</sup>, 2020 amending Section 10.25 Schedule of Fines and Fees of the Town of Thorntown Code of Ordinances; and

WHEREAS, the Town Council passed Ordinance 2021-08 on June 7<sup>th</sup>, 2021 further amending Section 10.25 Schedule of Fines and Fees of the Town of Thorntown Code of Ordinances; and

WHEREAS, the Town of Thorntown Advisory Plan Commission and the Town Council have reviewed the Schedule of Fines and Fees and now determine that the following amendments should be made to the Schedule of Fines and Fees to reflect current legislation and current practices in the Town.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF THORNTOWN, INDIANA, as follows:

Section 1: The Schedule of Fines and Fees is amended to **delete** the following fees under Police Department Enforcement –

<b>Gun Permit Fee:</b>	<b>\$50.00</b>
<b>Police Report:</b>	<b>\$5.00</b>
<b>VIN Certification:</b>	<b>\$5.00</b>

Section 2: The Schedule of Fines and Fees is amended to **add** the following under Residential Permit Fees –

<b>Pre-fabricated Sheds:</b>	<b>\$75.00</b>

Section 3: The Schedule of Fines and Fees is amended to **add** the following under Town Hall/Clerk –

<b>Permit for Work in Right of Way</b>	<b>\$25.00</b>

**Copies (IC 5-14-3-8)**

**\$0.10 per page for black and white  
\$0.25 per page for color**

Section 5: All other provisions of Ordinance No. 2020-07, Ordinance No. 2021-08, and other ordinances, not amended by this Ordinance, shall remain in full force and effect.

Section 6: This Ordinance shall be in full force and effect from and after its adoption and publication as required by law.
