

ORDINANCE NO. 2023-09

**AN ORDINANCE ESTABLISHING RATES AND CHARGES
TO BE COLLECTED BY THE TOWN OF THORNTOWN, INDIANA, FROM THE
CUSTOMERS SERVED BY THE MUNICIPAL ELECTRIC UTILITY OF SAID TOWN,
AND OTHER MATTERS CONNECTED HEREWITH**

WHEREAS, the Town of Thorntown, Boone County, Indiana (the “Town”) owns and operates a municipal electric utility for the purpose of providing and distributing electrical energy in the Town and surrounding areas; and

WHEREAS, pursuant to Indiana Code 8-1.5-3-8(f), municipally owned electric utility’s rates and charges are subject to the approval of the municipal legislative body by ordinance; and

WHEREAS, the Town previously adopted certain rates and charges for electric service for customers of the Thorntown Municipal Electric Utility pursuant to Ordinance 2022-08; and

WHEREAS, the Town has caused to be performed an electric rate analysis and, based upon said analysis, now wishes to modify the rates and charges for electric customers of the Thorntown Municipal Electric Utility; and

WHEREAS, the Thorntown Town Council finds the rates and charges set forth herein shall be adopted.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF THORNTOWN, INDIANA, as follows:

Section 1: Rates and charges for services rendered by the electric utility of the Town of Thorntown shall be as follows for each designated class of user:

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval according to law or otherwise as set forth herein.

Section 4: The rates and charges reflected herein will be effective beginning with the November 1, 2023 billing period, collected in November, 2023.
