Police:

Marshal Clark would like to add a fee for review of camera footage for Public Requests. He said the standard charge is \$150 per incident. Sara advised it was okay to proceed with obtaining a couple of quotes to remove the tree. This situation should be reviewed regarding ownership of the property.
